(November of 2018 year)

This newsletter refers to significant legislative amendments, which were made in November, 2018 in various legislative and sub-legislative acts.

Labor Code of Georgia

On the 30th of November, 2018 year, the amendment was made in the organic law of Georgia "The Labor Code of Georgia" and the first paragraph of its 3rd article was formed as follows: "Entities of the labor relations are employer or employer's association and employee and employee's association, which was created on the basis of goals and procedure provided with the conventions N: 87 and N: 98 of organic law of Georgia and international labor organization "on Trade unions" (Hereinafter – association of employees)."

Organic law entered into the force upon the official oath of the president of Georgia.

Civil code of Georgia

On the 30th of November, 2018 year, the amendment was made in the 3rd part of the 29th article of civil code of Georgia and it was formed as follows:

"3. Other rules of registration of non-entrepreneurial (non-commercial) legal entities shall be determined with the law of Georgia "on Entrepreneurs", with the law of Georgia "on Creative Workers and Creative Union" and with the organic law of Georgia "on Trade Unions".

Organic law entered into the force upon the official oath of the president of Georgia.

Resolution Nº69 of Batumi Municipality City Council

According to the sub-paragraph "a" of the part 17^{th} of the article 313^{th} of the code of administrative offences of Georgia, on the 30^{th} of November, 2018 year, Batumi Municipality City Council approved the response procedure of excess of the permissible standards of the acoustic noise and on administrative offenses, relate to the use of pyrotechnical material. The mentioned rule determines the response procedure on administrative offences, provided with the articles 77^1 and 77^2 of the administrative offences code of Georgia by the authorized person and the purpose of it is to measure the level of the acoustic noise in the residential houses, in the buildings of the real estate, existing in the private ownership and in the buildings of public institutions (hereinafter – "noise") and to provide the relevant measures in order to prevent administrative offences, provided with the articles 77^1 and 77^2 of the administrative offences, real to provide the relevant measures in order to prevent administrative offences, provided with the articles 77^1 and 77^2 of the administrative offences, real to provide the relevant measures in order to prevent administrative offences, provided with the articles 77^1 and 77^2 of the administrative offences code of Georgia, also to protect the citizens' rights and their legal interests.

The resolution entered into the force on the 30^{th} of November, 2018 year upon its promulgation.

Law of Georgia on Licenses and Permits

On 31st of October, 2018 year the amendment was made in the law of Georgia on "licenses and permits", in particular the 3rd paragraph of the Article 25th, which refers to the documentation, to be submitted to get the permission, was formed as follows: The statement should be attached: Extracts from public registry – for legal entities and individual entrepreneurs of private law (except for the cases, provided with the articles 24th, 28th and 281st of this law), and for the physical person – copies of the documents, confirming the identification and the copies of the documents, prescribed by the law of Georgia. A legal entity of public law should attach the certified copies of founding documents on the application".

The law entered into the force upon its promulgation on 31st of October, 2018 year.

Order №259/04 of the president of national bank of Georgia

On the 30th of November, 2018 year, in accordance with the order №259/04 of the president of the national bank of Georgia approved the regulatory rule of the specialized depository of accumulated pension scheme in accordance with sub-paragraphs "f" and "g" of the article 523, with the subparagraph "g" of the first part of the article 15th of organic law of Georgia on "the national bank of Georgia" and in accordance with the sub-paragraphs "a" and "c" of the paragraph 2nd of the article 6th of the law of Georgia "on accumulative pension". This rule has been drawn up in accordance with the law of Georgia "on accumulative pension" and determines:

- a) The requirements, should be satisfied by a person, who is eager to provide a depository service for the pension agency;
- b) The conditions for granting (hereinafter: authorization) / recognition and authorization / cancel of the recognition of the status, required for the specialized depository activity of financial institutions;
- c) Functions and duties of the specialized depository of the accumulated pension scheme; as well as the rules to submit periodic and current reports by him.

The order entered into the force on 30th of November, 2018 year, upon its promulgation.
