The present newsletter contains significant legislative changes made in various legislative and sublegislative acts in December 2020.

Joint Order of the Minister of Finance of Georgia and the Minister of Internal

Affairs of Georgia №299/166

On 10th of December 2020, number of legislative changes were made in the joint order of the Minister of Finance of Georgia and the Minister of Internal Affairs of Georgia dated of December 14th, 2011 №611-№1013 "on the establishment of the rules for checking up the execution of the permit conditions by the holders of gambling and other gaming licenses". Based on the mentioned changes, a sub-paragraph "L" of the second paragraph of article 5, which was confirmed by the the previous order, was formed as follows:

"L) Whether the organizer has a confirming act issued by the legal entity of public law operating in the field of governance of the Ministry of Internal Affairs of Georgia - Public Security Management

Center" 112 " to install the surveillance video systems.

2. A sub-paragraph ,,F" of the paragraph 2 of an article 8 was fomed as follows:

"F) Whether the permit holder has a confirming act issued by the legal entity of public law

operating in the field of governance of the Ministry of Internal Affairs of Georgia - Public Security

Management Center" 112 " to install the surveillance video systems.

The order came into force on 11th of December 2020.

The order No17 of the Director of Maritime Transport Agency of the

Ministry of Economy and Sustainable Development of Georgia

On 30th of December 2020, "the rule of working on the dock and execution of technical

supervision of the dock intended for floating means" was approved on the basis of the order №17 of the

Director of Maritime Transport Agency of the Ministry of Economy and Sustainable Development of

Georgia. The rules of working on the dock approved on the basis of the above-mentioned order defines

the rules of technical supervision, repair work and servicing of the dock intended to repair work of

private or state-owned vessels in Georgia.

The rule of working on the dock, approved by the previous order, specifies inspection standard of

floating dock, dry dock, slip and elling; minimal requirements of documents, provisions of control and

technical exploitation of machinery devices, technical exploitation conditions of the floating dock;

general prohibitions of vessels stopping in floating dock, working conditions in the dock, the rights and

obligations of a dockmaster and other relevant terms related to proceeding works in the dock.

The order was published on the website of the Legislative Herald on 31st of December, 2020. The

requirements established by the rule will apply on the floating dock in Georgia on the 90th day after its

publication and in certain cases, in accordance with the deadlines specified in an article 21 of this rule.

The order of the Minister of Finance of Georgia №326

On 30th of December 2020, based on the order No326 of the Minister of Finance of Georgia

a number of legislative changes were made in the instruction approved by the order №996 of

the Minister of Finance of Georgia of 31st of December 2010,,on Tax Administration".

The instruction has changed fundamentally, from which shall be mentioned several

important legislative amendments and additions. The amendments were made to the article

46, which regulates the registration conditions of VAT payers. Also, to the article 47th, which

regulates the conditions for cancellation of registration as a VAT payer, The chapter XVIII of

the instruction which is related to the VAT counting off has changed drastically.

The article 471 was also added to the instruction, which regulates the rules of calculating

VAT, payment to the budget and informing without the registration by a foreign taxable

person. An important addition is an article 482, which defines the cases of certain taxable

transactions, during which the content of the part 2 of the article 163 of the Tax Code of

Georgia is not used.

Besides certain articles, the chapter XII¹ was added to the instruction as well, which

strengthens the terms and conditions of the usage of part 7 of the article 160 of the Tax Code

of Georgia, chapter XII² has also been added to regulate transactions by voucher. An important

addition to the instruction is the chapter XVI1, which determines the rules for VAT taxation

in certain cases and the payment of VAT to the budget, as well as chapter XVI2, which

regulates special schemes.

The order came into force on 1st of January 2020.

The order of the Minister of Finance of Georgia №325

On 30th of December 2020, a number of legislative changes were made in the instruction

approved by the order №996 of 31st of December 2010 of the Finance Minister of Georgia "on

Tax Administration". Among them, article 93 was amended to the order, to issue a permit to

organize gambling and/or gaming, the delivery of gambling and/or gaming and it has been

clarified that the issuance of permits for arranging gambling and winning games and

delivering gambling and/or winning games is confirmed by the orders №VI-01, №VI-02, №VI-

03, №VI-04, №VI-05, №VI-06 , №VI-061, №VI-062 by issuing the relevant permit form of

annexes.

The amendments also affected the form of issuance of a license by the Revenue Service,

clarification of what is meant by the gambling business fee payment mark and what it should

contain, moreover, the paragraph 31 have been added to the instruction, which regulates the

amount of the gambling business fee which should be paid by the incentive raffle organizer

and the conditions of its payment.
