The present newsletter contains significant legislative amendments made in various legislative

and sub-legislative acts in March 2021.

The Law of Georgia on "Arranging Lotteries, Gambling and Gaming"

On 16th of March, 2021, legislative amendments were made to the Law of Georgia on

"Arrangement of Lotteries, Gambling and Gaming". Based on the mentioned amendments,

paragraph 3 of an article 311 of the Law was formed as follows:

"3. In the Council's composition should be included employees of the Ministry of Finance of

Georgia, the Ministry of Justice of Georgia, the Ministry of Economy and Sustainable Development

of Georgia and the Ministry of Culture, Sports and Youth of Georgia, as well as other persons

decided by the Minister of Finance.

The Law of Georgia on "General Education"

On 16th of March, 2021, significant amendments were made to the Law of Georgia on "General

Education". According to the amendments, several articles of the Law were amended and were

formed with a new edition. Amendments were also made on the branding subparagraph, on the

regulatory paragraph of the document of National Goals of General Education, on self-assessment,

on substitute teacher, small contingent school, online learning course of teacher training,

specialized school, the rules for receiving general education in the form of an external studies and

other articles that are important for the school administration to pay maximum attention to.

The Law of Georgia on "Structure, Authority and Rules of Operation of the

Government of Georgia"

On 16th of March, 2021, amendments were made to the Law of Georgia on "Structure,

Authorities and Rules of Operation of the Government of Georgia". Among the amendments of the

Law we should mark the amendment on the basis of which the functions and powers of the

Ministry of Education, Science, Culture and Sports of Georgia in the field of education and science

were transferred to the Ministry of Education and Science of Georgia. Amendments were also made

in various laws, where instead of the Ministry of Education, Science, Culture and Sports of Georgia,

the Ministry will be referred with a new name, namely, the Ministry of Education and Science of

Georgia.

The Code of "Local Self-Government"

On 18th of March, 2021, legislative amendments were made to the Organic Law of Georgia

"Local Self-Government Code". Based on these amendments, article 1634 with the following content

was added to the Code:

"Article 1634. For the purchaser of the property of privatized municipality in the form of an

auction (except Tbilisi), rule for changing or canceling the condition (conditions) related to the

property of the privatized municipality (except Tbilisi) in the form of an auction, for the recipient

of the property of the municipality (except Tbilisi) transferred with the right of use or transferred

with the right of management, due to the New Coronavirus (COVID-19) Outbreak or/and

Pandemic.

1. The Mayor of the municipality (except Tbilisi) is authorized to make a decision no later than

1st of October, 2021, by taking into account the interest of the municipality, in accordance with an

article 398 of the Civil Code of Georgia, with the consent of the municipal council, make a decision

for the acquirer of the property of the privatized municipality (except Tbilisi) in the form of an

auction, for the recipient of the property of the municipality (except Tbilisi) transferred with the

right of use or transferred with the right of management:

a) On the change of the investment condition related to this property, including the extension

of the term of fulfillment of the investment condition related to this property;

b) The cancellation of an obligation whose performance has lost its sense;

c) On the facilitation of the financial condition specified by the contract, including the

exemption from the penalty specified by the contract.

2. Receive the decision of the Mayor of the municipality, provided in paragraph 1 of this article

(except Tbilisi), is allowed, if non-completion or delay of the completion of the conditions specified

by the contract is due to the regulatory norms established directly as the result of the Epidemic

and/or Pandemic caused by the new coronavirus (COVID-19).

3. The type and size of the benefit determined by the decision of the Mayor of the municipality,

provided in paragraph 1st of this article (except Tbilisi), shall be proportional to the impact of the

regulatory norms referred in paragraph 2 of the same article on the fulfillment of the investment or

financial condition.

4. Decision of the Mayor of the municipality, provided in paragraph 1st of this article (except

Tbilisi), does not imply a reduction of the owing in exchange for the transfer of ownership. ".

Order of the Minister of Finance of Georgia Nº41

On 26th of February, 2021, according to the order of the Minister of Finance of Georgia, the rule of depositing and withdrawing money from the account in case of organizing lottery, gaming and/or gambling via system-electronic form was approved. According to this rule, depositing money from the gaming account and withdrawing money from the account is mandatory for the lottery

organizer and the holder of the gambling and/gaming, who carry out the activity via a system-

electronic form.

The above rule precisely defines the conditions of deposit and withdrawal money on the account and the obligations of the operator. It is important to emphasize that the violation of the rule approved by the order is a violation of the permit conditions, and in the case of a lottery organizer it is the violation of the terms of the contract and provides liability in accordance with

the rules established by the law.

Order of the Minister of Finance of Georgia №42

On 26th of February, 2021, based on the order №42 of the Minister of Finance of Georgia was

approved the rules for making accounting forms required for the implementation of activities for

the casino and gambling club permit holders. This rule establishes required rules and forms for

accounting, by the casino and gambling club permit holders to carry out their activities and obliges

the permit holders to act in accordance with the rules and accounting forms established by this

order. The order also includes definitions of the relevant terms, the obligations and authorities of

the permit holder regarding the rules of making accounting forms, etc.

table opening/closing accounting form, cash drawer's account form and sample for tips account

form.

Order of the Minister of Finance of Georgia №43

On 26th of February, 2021, by the order of the Minister of Finance of Georgia, the rules for

registration, identification and verification of a player via system-electronic form by the holder of

the lottery, gambling and/or gaming permit, was approved. According to the mentioned rule, The

holder of the permit for arranging lottery, gambling and/or gaming via system-electronic form is

obliged to register, electronically identify and verify the player in accordance with the conditions

defined by the above rule and face to face (nonelectronic) identification and verification of the

player in accordance with the "rules of identification and verification of the client by the

accountable person" approved by the Order №2 of the Head of the Financial Monitoring Service of

Georgia of June 5, 2020.

The above rule also defines the obligation of the operator to establish a business relationship

only with identified and verified persons in accordance with this rule. In addition to the above, the

rule also regulates the basics of identification and verification, player registration on the website,

operator obligations, etc.

Order Nº 996 of the Minister of Finance of Georgia dated 31st of December, 2010

on "Tax Administration"

On 5th and 16th of March, 2021, significant amendments were made into the Order of the

Minister of Finance of Georgia of December 31, 2010 "On Tax Administration". As a result of these

amendments, the issues regulated by the order have been fundamentally amended, from them

followings should be noted particularly: regulation of the taxable person to use his/her own

production facility/building as a fixed asset, data regulatory articles to be entered in the declaration,

regulatory norms of Tax invoice subscription, operation of goods/services exchange (barter),

certificate issued by the tax authority, refund of overpaid income tax by a tax authority to an

individual (employee) and in the case of importation of goods, the costs of transport and related

services of the mentiond goods.

In addition to the above, other articles of the Order were also amended and it's important to py

attention also to those articles.

Order №32/04 of the President of the National Bank of Georgia

On 9th of March, 2021 on the basis of the Order of the President of the National Bank of

Georgia, the rule of protection of Consumers Rights while providing services by financial

organizations was approved and declared invalid the Order of the President of the National Bank of

Georgia №151/04 of December 23, 2016 "On the Approval of the Rules for the Protection of

Consumers Rights in the Provision of Services by Financial Organizations"

The above rule regulates the rules and principles of protection of consumers' rights while

offering and delivering financial products, as well as providing financial services, which also

includes issues of consistent delivery of complete, necessary, understandable, truthful and timely

information. The aim of this rule is to promote financial stability and transparency of the financial

sector, also, ensuring information transparency on raising public confidence to the financial sector,

maximal protection of consumers interests and financial products on the market, which, will

significantly contributes the active use of new financial products by the consumer, as well as

reduction the various risks associated with them.

Besides the above-mentioned, the rule approved by the Order also regulates the obligation of

the financial organization in providing information on the financial product to consumers,

obligations of the financial organization in concluding a contract remotely and the disclosure of

significant risks related to specific financial products to consumers and other important provisions.

Order №002/02 of the Legal Entity of Public Law - Director of the Pension

Agency

On 16th of March, 2021, significant legislative amendments were made to the approval of the

instruction of the rules for payment of pension contributions, information submission forms,

administration of overpaid amounts, on pension contributions on individual pension account,

expenses, extra income, on other incomes, gains and lose in the Order N002 of July 30, 2019 of the

Director of the Pension Agency-Legal Entity of Public Law. According to the above amendments

paragraph 15 was added to the first article of the Order, which regulates the authority of the

Agency to use appropriate software in its activities. Besides above-mentioned, a number of other

articles were added to the Order, as well the Article 13 of the order, which regulates the rule of

pension payment error, underpayment or overpayment with a completely new version.

Order №38/04 of the President of the National Bank of Georgia

On 19th of March, 2021, on the basis of the Order №38/04 of the President of the National

Bank of Georgia, legislative amendments were made on approval of the rules for determining the

amount of fines, imposition and fulfilment "in the Order №17/04 of the President of the National

Bank of Georgia of 5th of February, 2020. According to these amendments, the title of the order

was changed and it was formed as follows: "on approval of the rules for determining the amount

of fines, imposition and fulfilment to currency exchange offices and their directors". Also, a

number of other amendments were made to the order, there should be emphasized the addition of

the article 3, in particular, about fines for facilitating the prevention of money laundering and

terrorist financing of Georgian legislation, on its basis legal acts issued by the National Bank,

written instructions, violation of requirements set as a result of inspection/supervision and/or

non-compliance with the instructions of the Financial Monitoring Service. The order precisely

defines the amount of sanctions and the procedure for imposing them.
