Order Nº01 of the Personal Data Protection Service

On 1st of March, 2022, the Resolution of the Personal Data Protection Service was defined, according to which the Service status and principles of the activities, the main directions of the Service, etc. were defined.

The Order №1-½ of the Head of the National Agency of Mineral Resources - Legal Entity of Public Law

On 2nd of March, 2022, by Order of the Head of the National Agency for Mineral Resources - legal entity under public law, the Regulation was approved on "holding an auction in order to issue the License for use of Minerals, determining the initial price for issuing the License and the payment rules".

Joint Order Nº611-Nº1013 of the Minister of Finance of Georgia and the Minister of

Internal Affairs of Georgia

On the 2nd of March, 2022 an amendment was made in the joint Order Nº611-Nº1013 of the Minister of Finance of Georgia and the Minister of Internal Affairs of Georgia made on December 14, 2011, "on the approval of the rules for verifying the compliance of the permit conditions by the permit holders of the winning game and other gambling ", according to which the regulatory scope of the order, the persons authorized to inspect, the procedure for carrying out the inspection by the Revenue Service with the person holding a permit for arranging gambling and winning games, etc. were

determined.
