The Law of Georgia on promoting the prevention of money laundering and terrorist financing

On the 11<sup>th</sup> of May, 2022, a number of amendments were made to the Law of Georgia on the promotion of the prevention of money laundering and terrorist financing which referred to the national report and action plan of assessing the risks of money laundering and terrorist financing, also preventive measures, key functions of the service, etc.

electronic tenders", according to which, within the framework of contracts concluded / to be

concluded for the procurement of construction works, in order to facilitate the

implementation of infrastructure projects, it is allowed to amend the value of the initially

concluded contract, on the basis of approval of the principles, rules and bases for the use of

price indexation in accordance with the rule provided by the Resolution Nº753 of the

Government of Georgia of April 27, 2022.

obtain the mentioned data from the electronic database of another administrative body.

19), by the order №829 of the Minister of Justice of Georgia on determining temporary rules

for the administration of the activities and its services to individuals, different from that

prescribed by the law, of a Legal Entity under Public Law - the National Bureau of

Enforcement ", it was determined that in order to start enforcement proceedings, the

creditor/applicant shall be given the right to submit the subordinate acts of enforcement

established by article 2 of the Law of Georgia on Enforcement Proceedings and the

documentation provided in the article 25 of the same law through the citizen's portal

my.gov.ge. And also within any proceedings (including Enforcement proceedings, simplified

proceedings, insolvency proceedings, etc.), the exchange of information/documents between

the National Bureau of Enforcement and the person/applicant participating in the proceedings,

## Order №257 of the Minister of Finance of Georgia

On the 18th of May, 2022 by the order No148 of the Minister of Finance of Georgia paragraphs 7 and 8 were supplemented to the article 6 of the instruction (Annex N8) "on declaration and registration of goods in the customs procedure or re-export" approved by the Order №257 of the Minister of Finance of Georgia "on approval of instructions on movement and registration of goods on the customs territory of Georgia" according to which, before the 1st of September, 2022, in order to use the benefits provided in the agreement between the Government of the Republic of Georgia and the Government of Ukraine on Free Trade, made on 9th of January 9, 1995, certificate EUR.1 with preferential origin issued in accordance with annexes I and II on the rules with preferential origin of Pan-Euro-Mediterranean sea" or certificate CT-1 with the preferential origin, issued in accordance with the decision signed in Minsk on 30th of November, 2000 by the council heads of independent states commonwealth "on the rule determining the state of origin of goods"may be submitted in the form of a certified copy signed and stamped (if any) by the declarant, in accordance with the requirements of this instruction - electronically or in material form. After the expiration of the period provided in paragraph 7 of this article, the declarant is obliged to submit the

original document of the certificate EUR.1 or CT-1 with preferential origin, submitted as a copy, to the customs authority, upon request.

Order №174/m of the Minister of Education and Science of Georgia

On the 20th of May, 2022 a number of amendments were made "in the procedure of starting and terminating of teacher's activity approved by the article 1 of the order №174/m of the Minister of Education, Science, Culture and Sports of Georgia on approval of starting and terminating of teacher's activity according to which the number and composition of commission members, including the chairman of the commission, is determined by the school principal according to the specific needs, based on the specifics of the vacant position of a teacher, but not less than three members, and in the case of a public school, not less than 5 members. Moreover, an independently invited specialist should be appointed as a member of the commission, sectoral department representative from the Department of the Ministry of Education and Science of Georgia (hereinafter - the Ministry) should also be appointed as a member of the Public School Commission, a representative from the Educational Resource Center of the relevant territorial body of the Ministry, representative of the National Center
