The present newsletter contains significant legislative amendments, made in various legislative and sub-legislative acts in September 2022.

The code of Administrative offences of Georgia

On 6th of September, 2022 amendments were made in the code of administrative offences of Georgia and part 5 of the article 177 was formed with the following addition:

"5. The person/organization to which an administrative fine was imposed for the committing of an administrative offense provided in the 3^{rd} or 4^{th} part of this article, repetition of the same action will result a fine from 2,000 GEL to 7,000 GEL.

Law of Georgia "On Payment System and Payment Services"

On 9th of September, 2022 following articles of the Law of Georgia "On Payment System and Payment Services" were formed with new edition: Article 4 (important system); Article 5

(exception from registration as an operator and implementation of payment system); Article 5¹

(access to the payment system); Article 13 (concept of payment service); Article 13¹ (Activities

permitted for payment service providers); Article 15 (Registration of a payment service

provider and implementation of payment services); Article 20 (providing information to the

user and/or concluding an agreement with him); Article 201 (Acceptance of payment

instrument and co-bagging) etc.

The law, except for the first paragraph of Article 20¹ of the Law provided in paragraph 13

of Article 1 of this Law, the first and fifth paragraphs of Article 222 of the Law provided in

paragraph 15 and the first and fourth paragraphs of Article 22³, paragraphs 5 and 6 of the 41¹

Law provided in paragraph 27 and chapter VI² shall enter into force from November 1, 2022.

Paragraphs 1 and 5 of Article 22² of the Law provided by the paragraph 15 of Article 1 of

the Law and paragraphs 1 and 4 of Article 22³ of the Law shall come into force on January 1,

2023.

Paragraphs 5 and 6 of Article 411 of the Law provided by the paragraph 27 of Article 1 of

the Law and chapter VI² will come into force from August 1, 2023.

The first paragraph of the Article 20¹ of the Law provided by the paragraph 13 of the first

Article of the Law shall come into force from January 1, 2025.

Law of Georgia "On Licenses and Permits"

On 9th of September, 2022 amendments were made to the Law of Georgia "on Licenses and

Permits" and article 94 with the following content was supplemented to the law:

"1. In order to promote the stability and development of the financial sector, as well as

based on the interests of the banking sector, among them, in order to use essentially new and

innovative financial technologies in the local market and increase consumer access to financial

services, the National Bank of Georgia is authorized to issue a conditional license to a legal

entity for the licensing of a commercial bank by temporarily simplifying the requirements

regarding the minimum capital established by the legislation of Georgia. When issuing a

conditional license, the National Bank is authorized to define appropriate restrictions and/or

individual/additional requirements, stages and deadlines for their full satisfaction, in order to

reduce risks.

2. The rules and conditions for issuing a conditional license for banking activities are

determined by the legal act of the National Bank of Georgia."

On 9th of September, 2022 Article 17 (Bank Secrecy) and Article 211 (Conducting Business

Relations with Clients) of the Law of Georgia "on the Activities of Commercial Banks" were

formed with a new edition.

Organic Law of Georgia "On the National Bank of Georgia"

On 9th of September, 2022 in the Organic Law of Georgia "on the National Bank of Georgia" Article 2 (Definition of Terms), Article 9 (Powers of the Board of the National Bank), Article 48 (Supervisory Powers of the National Bank), Article 48² (Registration and supervision of payment system operator and payment service provider), Article 50² (Protection

of confidential information via the currency exchange office), Article 52² (Supervision of the activity of the lending entity), Article 64² (Commission for reviewing disputes in the field of

payment system and payment services with the National Bank) and Article 66¹ (National

Payments Council) were formed with a new edition.

On 23rd of September, 2022 Articles, about approval of the instruction "on the public register", 10 (notice on public-legal restriction), 11 (issuing information from the technical accounting archive) and 58 (general rules for verifying the authenticity of the signature) were formed with a new edition.

Order №174/m of the Minister of Education and Science of Georgia

On 22nd of September, 2022 paragraph 2¹ with the following content was supplemented to the 2nd paragraph of the first article of the "Rules for starting and terminating the activity of a teacher" approved by the first article of the Order N174/m of the Minister of Education, Science, Culture and Sports of Georgia made on August 20, 2019 "on approval of the rules for starting and terminating a teacher's activity"

"2¹. Mentioned rule does not apply to persons who desire to be employed in the Ukrainian sector at a school. The mentioned persons will be selected according to the rules established by the school."

Order №996 of the Minister of Finance of Georgia

On 23rd of September, 2022 an amendment was made to the instruction approved by Order

№996 of the Minister of Finance of Georgia made on December 31, 2010 "on Administration

of Taxes" and sub-paragraph "g", paragraph 2, Article 812 was formed with the following

redaction:

"g) to ensure to take out only the labeled/marked products for sale according to the rules

established by this order. In addition, even the product on which it is not possible to fully or

partially read/recognize the non-material form stamp applied by the selected person is

considered as labeled/marked.

Resolution №99 of the Government of Georgia

On 16th of September, 2022 in accordance with the paragraph 4, Article 20 of the Organic Law of Georgia "on Normative Acts", an amendment was made to the Resolution Nº99 made on February 10, 2020 of the Government of Georgia "on approval of the rules and conditions of entry and checking (inspection) at objects subject to inspection" and Article 2 (definition of terms), Article 6 (types and directions of inspection), Article 10 (other measures to be implemented at the site), Article 11 (scheduled and unscheduled inspection), Article 12 (implementation of inspection and its legal bases), Article 23 (Protocol and Reference on Administrative Offenses) and Article 26 (Rule of Carrying out Repeated and Subsequent Inspection(s)) of "rules and conditions of entry and checking (inspection) of facilities subject to inspection" approved by resolution were formed with a ned edition.

Resolution №322 of the Government of Georgia

On 27th of September, 2022 in accordance with paragraph 4, Article 20 of the Organic Law

of Georgia "on Normative Acts", an amendment was made to Resolution №322 made on May

23, 2020 of the Government of Georgia "on approval of isolation and quarantine rules" and in

Article 11 of the "Isolation and Quarantine Rules" approved by the resolution:

1. Paragraph 4 was formed with the following redaction:

"4. People who were in contact with a person with COVID-19 are not subject to isolation,

in addition, it is strongly recommended to use a mask for the next 10 calendar days after the

cessation of high-risk contact (including when entering a low-risk environment, in places of

public gathering, in public transport, at home, avoiding such places where it is impossible to

use a mask (eg: in food establishments, etc.))."
