Legal Newsletter (June 2023)

The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in June 2023.

Administrative Procedure Code of Georgia

On the 13rd of June, 2023 "Chapter VII25 (administrative proceedings regarding receiving information from the service provider) was supplemented to the Administrative Procedure Code of Georgia."

The Law will enter into force on the 190th day of its publication.

Law of Georgia on personal data protection

On the 14th of June, 2023 The Law of Georgia on personal data was formed with a new redaction. The old version of the Law is annulled since the 1st of March, 2024.

The Law, with the exception of Articles 1-87, paragraphs 2 and 3 of Article 88 and Article 89

of this Law, shall come into force upon their publication.

Articles 1-5 of the Law, sub-paragraphs "a"-"q" of the first paragraph, Article 6, paragraphs 2

and 3, articles 7-30, 32, 34-79, 81 and 83-87, paragraphs 2 and 3 of Article 88 and Article 89

will come into force from 1st of March 2024.

Articles 31, 33, 80 and 82 of the Law will come into force from the 1st of June, 2024.

Sub-paragraphs "r" and "s" of the first paragraph of Article 6 of the Law will come into force

from the 1st of January, 2025.

Civil Code of Georgia

On the 15th of June, 2023 the first part of Article 802 of the Civil Code of Georgia was formed

with the following redaction:

"1. The insurer is obliged to hand over physically or electronically signed document about the

insurance contract to the insured (insurance certificate (policy)). In addition, the electronic

document issued by the insurer must be certified with a qualified electronic signature and/or a

qualified electronic stamp. It is permissible for the insurer to deliver the insurance certificate

(policy) to the insured electronically, in accordance with the procedure established by the

legislation of Georgia."

Law of Georgia "on Enforcement Proceedings"

On the 15th of June, 2023 paragraph 2, Article 54 of the Law of Georgia on Enforcement

Proceedings" was formed with the following redaction:

"2. In the case of execution of monetary claims stipulated by several enforcement papers

against one debtor by different executors the debtor's same property is sold by auction or in

another way by the executor who first registered the sequestration of the weapon and

auxiliary technical means of transport facility and agricultural machine determined by the

first paragraph of Article 53 of the Law of Georgia "On Traffic" in the relevant body of the

Ministry of Internal Affairs of Georgia, on civil aircraft - in the State Register of Civil Aircraft,

on ultralight aircraft - in the Register of Ultralight Aircraft, on sea vessels - in the State

Register of Georgian Ships, on securities - with the relevant person producing the securities

register, and on other property - in the public register. The sequence of enforcement is

determined by the time of registration of sequestration of the property (hourly and

minutely)."

the authority to lead/represent this person and/or is a member of the governing body of the

said person.

Atlantic Treaty Organization (NATO) operation, a specialized vehicle intended for the

transportation of medical oxygen or perishable liquid (except for those moved in transit).

"2. The provider (acquirer/sub-acquirer) is authorized to provide acquiring services to a

foreign company implementing gaming business, if the provider (acquirer/sub-acquirer)

ensures the restriction of payment operations in favor of foreign companies implementing this

gaming business with card instruments issued by commercial banks and microbanks,

registered payment service providers and microfinance organizations licensed by the National

Bank of Georgia."

3. The sub-paragraph ,,a" of paragraph 3, article 4 was formed with the following redaction:

"a) In case of transfers via SWIFT: name of the recipient, account number of the recipient,

name of the commercial bank/microbank serving the recipient and BIC;
