The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in August 2023.

Order №47/04 of the President of the National Bank of Georgia

On the 1st of August, 2023 by order Nº194/04 of the President of the National Bank of Georgia an amendment was made to the Order Nº47/04 of the President of the National Bank of Georgia made on the 13th of June, 2014 "on approval of the Regulation on Operational Risk Management by Commercial Banks" and sub-paragraph J¹ was supplemented to paragraph J, Article 2 (outsourcing risk) paragraph 5 of Aeticle 4 (directorate) was formed with a new redaction and etc.

Order №70/04 of the President of the National Bank of Georgia

On the 3rd of August, by order №205/04 of the President of the National Bank of Georgia a number of amendments were made in the order №70/04 of the President of the National Bank of

Georgia made on the 15th of May, 2017 "on the approval of the regulation of the liquidity coverage

ratio of commercial banks", in particular, sub-paragraph F with the following content was

supplemented to the Article 2:

"F) A financial instrument of the first level credit risk category - a financial instrument that

meets the criteria of the first level credit risk financial instruments provided by the "rules for

determining the risk categories of financial instruments and expected credit loss" approved by the

order of the President of the National Bank of Georgia.

2. paragraph 3 of Article 5 was formed with the following redaction:

"3. During calculating the expected cash inflows, the bank should take into account the

contractual inflows only from the financial instruments of the first level credit risk category, whose

reclassification is not expected within the next 30 days."

3. paragraph 1 of Article 6 was formed with the following redaction:

"1. The liquidity coverage ratio shall be calculated and applied for each day. The daily liquidity

coverage ratio must be reported to the National Bank no later than the next 2 working days. If the

bank expects a violation of the limits defined by paragraph 3 of Article 3 of this regulation, it is

obliged to immediately notify the National Bank."

On the 4th of August, 2023 by the Order Nº297 of the Minister of Finance of Georgia an

amendment was made to the instruction "on Tax Administration" approved by the Order №996 of

the Minister of Finance of Georgia made on the 31st of December, 2010 and paragraph 13 of Article

112 was formed with the following redaction:

"13. Until December 31, 2025, the selected person will be reimbursed the nominal value of

mandatory marking of non-excise goods by the Revenue Service, based on the contract signed with

the selected person.

The Order came into force upon its publication and extended to the legal relationships arising

from the 1st of August 1, 2023.

In the same Instruction, on the 14th of August, 2023 by order №300 of the Minister of Finance

of Georgia, an amendment was made and Article 483 with the following content was supplemented

after the Article 48²:

"Article 483. In the case of exchange (barter) transactions, determination of the amount taxable

by VAT with the market price

If an immovable object is delivered within the scope of an exchange (barter) operation, the

amount taxable with VAT for each party of the operation shall be determined by the market price

of the acceptable goods/services without VAT.

Example 1. An exchange agreement was signed between an enterprise and a natural person.

According to the contract, a natural person transfers a plot of land to the ownership of the

enterprise, and in return, the enterprise shall build a construction on the same plot of land, in

which part of the area shall be transferred to the ownership of the natural person. The market price

of the land is 236,000 GEL.

of the Minister of Finance of Georgia and paragraph 4 of Article 46 (registration as a VAT payer);

Article 77 (filing of the excise declaration); Article 812 (rights and obligations of business entities

and the selected person during the implementation of mandatory marking of excise goods/non-

excise goods by the selected person); Paragraphs 66 and 67 of Article 112 (transitional provisions)

were formed with a new edition.

amendment was made to the Order No10/04 of the President of the National Bank of Georgia made on the

11th of February, 2011, "on approval of the rules for compliance with minimum reserve requirements by

Order №142/04 of the President of the National Bank of Georgia

On the 4th of August, 2023 by the Order Nº212/04 of the President of the National Bank of Georgia an amendment was made to the Order Nº142/04 of the President of the National Bank of Georgia made on 21st of July, 2020 "on approval of the rules of activity of foreign exchange market participants" and in the "rule of activity of foreign exchange market participants" approved by this order:

1. paragraph 3 of the first article was formed with the following redaction:

"3. Compliance of the norms defined by this rule is mandatory for licensed commercial banks, licensed microbanks, licensed brokerage companies and registered microfinance organizations participating in the foreign exchange market of Georgia, which operate in accordance with the "rules for electronic trading with currency using the Bloomberg trading system" approved by the

President of the National Bank of Georgia (hereinafter referred as the "organized market").

2. Sub-paragraph ,,B" of Article 2 was formed with the following redaction:

"B) Participation in the foreign exchange market - participation in the foreign exchange market is considered to be the regular implementation of foreign exchange transactions with each other or with clients by commercial banks, microbanks, brokerage companies and registered microfinance

organizations licensed by the National Bank of Georgia;

clearance of goods in the customs territory of Georgia" was formed with the following redaction:

"8. In special cases determined by the individual administrative-legal act of the Minister of

Finance of Georgia, the 10-year limitation of the general period of placing goods in the temporary

importation procedure established by the Part 4 of the Article 139 of the Customs Code of Georgia

does not apply, including if the said goods are used:

registration of a labor immigrant employed in Georgia by a local employer in the unified database

of the Ministry of Labour, Health and Social Protection of IDPs from the occupied territories of

Georgia" (Appendix №2).

On the 30th of August, by the Resolution №334 of the Government of Georgia in accordance

with paragraph 4, Article 20 of the Organic Law of Georgia "on Normative Acts", an amendment

was made to the Resolution No511 of the Government of Georgia made on the 1st of December,

2017 "on approval of requirements for the technical qualification of technical regulations" -

"periodic technical inspection centers for motor vehicles, buildings, equipment and personnel" of

the Government of Georgia of December 1, 2017 and subparagraph "O" of the first paragraph of

Article 2 of the technical regulations approved by the resolution was formed with the following

redaction:

"O) Unified electronic database – a unified electronic program of periodic technical inspection

developed by a legal entity under public law - a unified national accreditation body - an

accreditation center, in which all inspection centers are involved and which ensures the collection

of data received from inspection centers in a unified information system, verification and

confirmation of received data, access to data necessary for inspection purposes for inspection

centers, analysis of inspection results, production of multifaceted statistics, for authorized public

institutions (Informational and analytical department of the Ministry of Internal Affairs of Georgia,

legal entity under public law – Service Agency of the Ministry of Internal Affairs of Georgia, Patrol

Police department of the Ministry of Internal Affairs of Georgia, LEPL - Unified National

Accreditation Body - Accreditation Center, LEPL - Land Transport Agency, Georgian

Department of Environmental Supervision), in order to carry out the tasks within their competence, simplified access to inspection results (except user's personal data) and secure data exchange. The data related to the inspection to be entered by the inspection center in the unified electronic database (which does not include the list of personal data of the user) is determined by the decree of the general director of LEPL - National Accreditation Agency - Accreditation Center.
