The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in February 2024.

Order Nº77/04 of the President of the National Bank of Georgia

On the 2nd of February, 2024 by the Order №21/04 of the President of the National Bank of Georgia paragraph 12¹ with the following content was supplemented to the Rule №77/04 of the President of the National Bank of Georgia made on the 1st of May, 2023 "on the approval of the registration and regulation rules of Payment Service Provider".

"12¹. if the administrator/administrators of the interested person and/or the direct/indirect also beneficial owner (owners) of significant share/person with significant influence owns a share(s) in the entity(ies) under the supervision of the National Bank or represents an administrator in the entity(ies) under supervision of the National Bank and has passed at least the relevant and/or more complex suitability check of the administrator/administrators and/or significant share both direct/indirect and beneficial owner(s)/person with significant influence in the National Bank, National bank is authorized to take into account the information/documentation submitted to the National Bank during the determination of suitability and no longer require the interested person to submit the information/documentation specified in subsections "L", "M", "N", "O" and/or "P" of Article 3, paragraph 2 of this rule.

Order №996 of the Minister of Finance of Georgia

On the 5th of February, 2024 by the Order №37 of the Minister of Finance of Georgia, an amendment was made to the instruction №996 of the Minister of Finance of Georgia on "Administrations of Taxes", made on the 31st of December, and Article 47 (cancellation of registration as a VAT payer) and etc. was formed with new redaction.

Order №06/M of the Minister of Education, Science and Youth of Georgia

On the 12th of February, 2024 by order №24/M of the Minister of Education, Science and Youth of Georgia an amendment was made to the Order №06/M of the Minister of Education, Science, Culture and Sports of Georgia made on the 29th of January, 2019 on ,, the approval of rules and conditions for the protection of safety and public order in a general educational institution" and Article 3 (mechanisms for the protection of safety and public order); Article 9 (receiving psychological help), etc. were formed with a new edition.

The order, except subparagraph "a" of paragraph in article 1 and subparagraph "c" of paragraph 2 of this order, is effective immediately upon publication.

Sub-paragraph "a" of the first paragraph of the first article and sub-paragraph "c" of the 2nd paragraph of the order shall come into force immediately after publication and its effect shall be extended to the legal relations arising from the 1st of January, 2024.

Order Nº34/04 of the President of the National Bank of Georgia

On the 14th of February, 2024 the liquidation rule of the microfinance organization was approved along with the attached appendix and the order № 59/04 of the President of the National Bank of Georgia made on the 5th of April, 2018 "on approval of the liquidation rule of the microfinance organization" was declared invalid.

Order Nº28/M of the Minister of Education, Science and Youth of Georgia

On the 15th of February, 2024 by order №28/M of the Minister of Education, Science and Youth of Georgia in Article 2 of the "General Educational Institution manual/series grading rule" approved by the first article of the Order №28/M of the Minister of Education and Science of Georgia made on the 16th of February, 2017" on the approval of the rules for grading the manual/series of the general educational institution"

1. Sub-paragraph "h" was formed with the following redaction:

"H) Manual maquette questionnaire (hereinafter - questionnaire) - a document that contains information about a specific manual maquette. The requisites of the questionnaire

are approved by the Minister of Education, Science and Youth of Georgia (hereinafter - the Minister) with individual administrative-legal act ;".

2. Sub-section "P" was formed with the following redaction:

"P) Applicant - a natural or legal person/persons, who submit/submits a registration application to the Ministry of Education, Science and Youth of Georgia (hereinafter referred to as the Ministry) with a request to grant certification for a specific textbook/series model;

Resolution №257 of the Government of Georgia

On the 29th of February, 2024 according to the Resolution №58 of the Government of Georgia in accordance with paragraph 4 of Article 20 of the Organic Law of Georgia "on Normative Acts", an amendment was made to Resolution №257 of the Government of Georgia made on the 31st of May, 2019 "on the rule for issuing construction permits and permit conditions for facilities of special importance (including radiation or nuclear facilities) and in the Resolution:

1. Article 47:

A) Sub-paragraph "m" with the following content was supplemented to the first paragraph:

"M) Reduction of plots of land to be used for construction during the construction of highways of international and/or domestic significance and/or engineering structures on them, on which no construction works were carried out.";

B) Paragraph 3¹ was supplemented after the paragraph 3.

"3¹. In the case of making amendments in the construction document specified by subsection "m" of the first paragraph of this article, the customer is obliged to submit the corrected data of the plots of land to be used for construction to the agency. The agency confirms the amendment made in the construction document in written form. The letter of agreement is an integral part of the construction permit and must be attached to all copies of the construction documents defined by this resolution.";

C) Paragraph 4 was formed with the following redaction.

"4. The amendments specified in the construction document under the first paragraph of this article (except for the cases provided in paragraphs 3 and 31 of this article) during the procedure of putting the building into operation are permissible amendments, and they are confirmed in the manner provided in paragraph 6 of article 66 of this resolution."

2. Chapter XIX² was supplemented after the XIX².
