The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in March 2024.

Order №243 of the Minister of Finance of Georgia

On the 29th of March, 2024 by Order №104 of the Minister of Finance of Georgia the following amendment was made in Order №243 of the Minister of Finance of Georgia made on the 1st of October, 2020 "on the establishment/introduction into the action of requirements/standards, which must be met by the essential products/services, POS terminal and/or any other device used/to be used by the applicant/permit holder for a permit to arrange gambling and winning games, a permit to provide gambling and/or winning games"

- 1. Sub-paragraph "d" with the following content was supplemented to the first article of the order:
 - "d) "Central system requirements/standards" (Appendix №4).
 - 2. "In requirements/standards (Appendix №2) for gaming machines" approved by order:
 - a) in the first article:
 - A.a) the first paragraph was removed;
 - A.b) paragraph 7 with the following content was supplemented after paragraph 6:

"7. Player card – a card given to the player by the operator during player registration, which is assigned a unique number of the player and through which the player's deposits, deposited, withdrawn, won and/or lost amounts are reflected in the central system.";

b) sub-paragraph "A.E with the following content was supplemented to sub-paragraph "A" of the first paragraph of Article 6":

"A.E) The banknote receiver shall be activated only after a valid player's card is placed in the card reader of the gaming machine."

3. "Central System Requirements/Standards" (Appendix Nº4) was supplemented to the order with the attached redaction.

The person is obliged, no later than March 1, 2025, to carry out the assessment provided in subparagraph "f" of the first paragraph of Article 3 of the "Central System Requirements/Standards" (Appendix №4) approved by this order and to submit a copy of the assessment report to the selected person, from April 1, 2024 to the period up to December 31 of the year.

The order, except sub-paragraph ,,b", paragraph 2 of the first article of this order, is effective from April 1, 2024.

Sub-paragraph "b", paragraph 2 of the first article of the order, will come into force on May 1, 2024.

Tax Code of Georgia

On the 6th of March, 2024 an amendment was made to the Tax Code of Georgia and Article 4 (retirement period); Article 238 (Ensurement of payment of tax debt by the tax authority), etc. were formed with a new redaction.

The Law, except sub-paragraph,,a" of paragraph 4 of the first article of this Law, came into force immediately after its publication.

Sub-paragraph "a", paragraph 4 of Article 1 of the Law came into force from April 2, 2024.

The effect of sub-paragraph "a" of section 4, the first article of the Law was extended to legal relationships arising from April 1, 2024.

Code of Spatial Planning, Architectural and Construction Activities of Georgia

On the 7th of March, 2024 The following amendment was made to the Code of Spatial Planning, Architectural and Construction Activities of Georgia:

1. Section 9 of Article 141 was formed with the following redaction:

"9. Up to the 1st of December, 2025 the expert assessment and technical supervision of the permit documentation defined by this code is carried out by the persons specified in the temporary rule for the expert assessment and technical supervision of the permit documentation together with the accredited inspection bodies and certified experts.

- 2. Section 7 of Article 144 was formed with the following redaction:
- "7. Article 140 of this Code is suspended until December 1, 2025."

"Article 2016

1. If the date of birth indicated in the identity document issued before the entry into force of this article differs from the date of birth indicated in the record of the birth act and/or birth certificate of the owner of this document, after the entry into force of this article, the same date of birth, which is indicated in the identity document issued before the entry into force of this article, will be placed on each new identity card of a citizen of Georgia, each new passport of a citizen of Georgia, and each new passport of a citizen of Georgia for official use, with his consent. For the purposes of this paragraph, an identity document issued before the entry into force of this article means any of the following documents issued last before the entry into force of the same article: valid or invalid identity card of a citizen of Georgia, valid or invalid passport of a citizen of Georgia, valid or invalid passport of a citizen of Georgia.

2. The record (date of birth) made in accordance with the same paragraph on the new identity card of the citizen of Georgia, on the new passport of the citizen of Georgia or the new passport of the citizen of Georgia provided in the first paragraph of this article cannot be the basis for cancellation of this identity card of a citizen of Georgia, this passport of a citizen of Georgia or this passport of a citizen of Georgia for official use."

Law of Georgia "on Architectural Activities"

On the 7th of March, Article 191 of the Law of Georgia "on Architectural Activities" was formed with the following redaction:

"Article 19¹. Certification of architectural activities in the transition period

The architect shall not be required to possess the relevant certificate until December 1, 2025, in order to certify the architectural project provided in the first paragraph of Article 4 of this law."

The effect of Article 191 of the Law of Georgia "on Architectural Activities" provided with the first article of the Law was extended to legal relationships arising from March 1, 2024.

Order №996 of the Minister of Finance of Georgia

On the 14th of March, 2024 by Order №80 of the Minister of Finance of Georgia amendments were made to Order №996 of the Minister of Finance of Georgia made on the 31st of December, 2010 "on Tax Administration" and after Article 39⁴ of the instruction, Article 395 was supplemented (submission of information by the lessee of stationary trading facilities and non-stationary trading places intended for the sale of goods on the territory of the market) and paragraph 69 with the following content was supplemented after paragraph 68 of Article 112:

"69. A person, who leases a stationary trading facility and/or a non-stationary trading place in the territory of the market, and the said lease relationship was established before April 1, 2024, is obliged to submit the information provided in the first paragraph of Article 395 of this instruction to the tax authority no later than May 31, 2024."

On the 20th of March, 2024 The "rules for filling out and submitting information of monitoring the risk of money laundering and terrorism financing of entities lend loan" were approved along with the attached annexes.

The order №183/04 of the President of the National Bank of Georgia made on October 9, 2020 "on the approval of the rules for filling out the reports and presenting information of monitoring the risk of money laundering and terrorism financing of entities lend loan" was declared invalid.

- a) The first paragraph was formed with the following redaction:
- "1. Regarding the entity registered before January 1, 2022, which did not bring the registered data into compliance within the period established by the first paragraph of Article 254 of the Law of Georgia "on Entrepreneurs", an extract from the register is issued without limitation, in the form of an extract valid until January 1, 2022, where the information on the obligation to bring the registration data into compliance with the law is reflected. In case of non-fulfillment of this obligation within the established period, the entity's registration is suspended, it is indicated in the register, and an extract from the register is no longer issued.";
 - b) Paragraph 2 was deleted.
